## 4. REPORT FROM PRESIDENT

The President provided an overview of key events in 2010.

- a. **Gaming Funding** – Cycling BC is a provincial organization and as such is eligible for up to \$250,000 per year, We have received this amount in each of the past three years,
- b. **High Performance** – great results nationally and internationally
- c. **Rider Insurance** – Cycling BC has a favorable claims history and due to frustrations with the national program operated by the Canadian Cycling Association we will attempt to build a sustainable provincial insurance program commencing 2011.
- d. **Thank You** – The President thanked all board members and volunteers for their valuable time and energy throughout the past year.

## 5. REPORT FROM CHIEF EXECUTIVE OFFICER

The CEO

- a. **License Cards** – new plastic license very popular
- b. **Membership Types** – many switching from associate to citizen racers and better tracking of number of mountain bikers versus road racers
- c. **Online Registration** – new system to be used in 2011 is CCN Cycle Component Networks which specializes in race results
- d. **Insurance Program** – need to review current service level related to excellent claims history
- e. **Commissaire Development** – priority, but always a challenge
- f. **Schools Program** – new initiatives in place to encourage secondary students to basic and competitive skills

- g. **Funding Changes** – end of three year commitment of gaming, but secured three year commitment of provincial coaching grant money
- h. **Cash Flows** – many peaks and valleys with government funding
- i. **Growth of Mountain Biking** – sport has grown in last 3-5 years, and will have big shoes to fill with the loss of Tanya Camposano as the Mountain Bike Director at end of August 2010

## 6. REPORT FROM VICE-PRESIDENT FINANCIAL OVERSIGHT

- a. **Small Surplus** – 2009
- b. **Revenues** – 2009 saw increase, now over \$1M and 50% of gross is from government agencies
- c. **Membership and Fee Changes** – addition of U13/U17/U23 youth licenses to make starting the sport more affordable
- d. **Learn to Ride Programs** – expanding to club, community centre and retail outlet level

## 7. REPORT FROM VICE-PRESIDENT ROAD AND TRACK

- a. **Portfolio** – now just road and track
- b. **Interior** – lost one Okanagan event
- c. **Lower Mainland** - added Richmond Criterium
- d. **BC Champs** – on Island (Victoria) which was most successful
- e. **Grand Fondo** – positive effect will likely continue with growth from Vancouver to Whistler only race to 3 different races in 2011
- f. **Superweek** – saw loss of Gastown due to economy downturn and loss of sponsor

## 8. REPORT FROM VICE-PRESIDENT MOUNTAIN BIKE

- a. **Overall** – very successful; especially in downhill and xc marathon
- b. **BC Cup Package and Series** – added and very successful
- c. **Timing System** – accurate and immediate race results

- d. **Points Tracking** – now immediate and used in Test of Metal Series
- e. **National DH Champs** – saw over 175 riders

#### 9. REPORT FROM VICE-PRESIDENT CYCLO-CROSS

- a. **Sport Growth** – now 18 events in 3 months (Sep – Nov)
  - i. **6 are BC Cups**
  - ii. **6 are Island Series**
  - iii. **2 are Interior Events**

Overall, 2010 saw record participation with 180 at Vanier Park and averaging 140-180 participants at every race. However, the strongest growth in citizen and master men's and lowest participation is in youth / women's categories.

- b. **Upgrade points** – separate upgrade points in CX
- c. **2011 series** – will be in lower mainland, interior and island with free kids races and a focus on increasing women's and youth participation

#### 10. REPORT FROM VICE-PRESIDENT BMX

- a. **FUN-damentals** – BMX is a great entry point sport teaching riders fundamental skills in the sport of cycling
- b. **“NEW” Clubs** – reopened Big Pine BMX in Kamloops and North Shore BMX (old Inter-River Club) ran a full season
- c. **Youth Licenses** – added the U13/U17/U23 licenses to make sport more affordable
- d. **Super-Cross Track** – hope to raise enough funding to develop Abbotsford into Super-Cross Track

#### 11. REPORT FROM VICE-PRESIDENT PARA-CYCLING

- a. **NEW Discipline** – this position added to the Board in 2010
- b. **NEW Sport** – hosted a Para-Cycling event that saw 8 attendees
- c. **Sport Growth** – hope to grow the sport in BC

#### 12. REPORT FORM VICE-PRESIDENT RANDONNEUR

- a. **Overall Comments** – lots of mileage, more events & ambitious schedule
- b. **March 20<sup>th</sup>** – 47 people
- c. **Hell Week** – 16 people from 30 to 67 years of age
- d. **Super Week** – 2500 km / 10 days and 26 people
- e. **XXX Event** – 41 started and 31 finished
- f. **Eleventh Hour Race** – to come Remembrance Day 2010
