National Insurance Coverage

Each UCI / CCA/Citizen licensee has access to:

- \$5M 3rd Party Liability insurance plus Sport Excess Medical insurance; this includes the popular benefits such as Ambulance transport, physiotherapy, fractures, prescription eyeglasses incurred within 52 weeks of date of accident
- Insurance coverage is not 24-hr coverage; team and club members are covered during their respectively registered team and club activities as listed each affiliate's application form and during events sanctioned by the CCA and Cycling BC
- Team and Club Members have 30 days to report an injury if an accident occurs while participating in their respectively registered team and club activities
- Bikes, Riding Equipment and/or Personal Belongings are not covered by this policy

Coach's & Organizer's Insurance

This is the same policy as rider insurance, but while the member is working in a technical role (coach, instructor, organizer, manager, mechanic, or driver). Some technical licenses require certification (i.e. NCCP or CBC Prov C Commissaire Levels) and a code of conduct must be signed.

Director's & Officer's Insurance

This is a separate policy which provides coverage in the case of wrongful decision-making

- * Policy runs from March 1st to April 30th
- * Applications are requested from our office
- * Most Common Example: a club member is disgruntled regarding a decision made by the club's executive



Cycling BC is the provincial governing body for the sport of cycling in British Columbia. We represent the disciplines of Road, Track, Cyclocross, Mountain Bike, and BMX.

Out of Country Insurance

(club members racing outside Canada)

- It is highly recommended that all team members purchase additional out of country medical while training /competing outside of the country in approved activities
- The insurance provided with a UCI/CCA license is NOT valid outside of Canada
- The rate is \$5/day, please contact the office via email to info@cyclimgbc.net
- Info required: rider's full name, address, date of birth, provincial trade team / club name, full event name and coverage dates

Definition - Trade Team

Trade Teams are privately owned entities with self-selected memberships. On-site race support is often provided to members including coaching, technical, and managerial services. Trade Teams organize races, training rides, and social activities either for its own members, or members of other clubs, teams, or UCI/CCA license holders.

Trade Team versus Club

- All Trade Team members hold a UCI/CCA race license; club members can have a citizen, or an associate club membership and not race.
- Trade Team members are invited to be part of a team; clubs welcome new members & have an open membership policy
- Trade Team is owned by a business or person.

Team versus Club cont'd

- Clubs are not owned, they are run by a Society which has a board of directors, with at least 5 riders who are part of general membership who also hold a race license.
- Trade Team members usually ride at the Cat 1/2 level for road and Pro-Elite for mountain.
- Trade Team members may be under contract and receive free apparel, equipment, trips.
