13. Elections:

Please note that nominees were asked to limit their speeches to 1 min.
Diana Hardie and Lister Farrar were assigned the duties of vote counters.
[NOTE that in future notes **VP=Vice President**]

PRESIDENT: Stuart Lynne nominated Bruce Denis for President. Bruce Denis accepted. No other candidates came forward;

Thus, Bruce Denis is President by Acclamation.

VP Cycling for All: Noah Bloom nominated Brett Boniface. Matthew Chater nominated Alex Pope but Alex Pope declined;

Thus, Brett Boniface is VP Cycling for All by Acclamation.

VP Mountain Bike: Nicole Rochefort nominated Kevin MacCuish for VP MTB, and Matt Hornland nominated Patrick Beckstead for VP MTB. Both accepted their nominations, so the position goes to a vote. Votes counted and 58 ballots were cast 31 for Patrick Beckstead and 27 ballots were cast for Kevin MacCuish;

Thus, Patrick Beckstead is voted in as VP Mountain Bike.

VP Para-cycling: John Noonan called for nominations, but no one accepted at this time;

Thus, the VP Para-cycling position remains vacant, with the Board having the ability to appoint someone to that position later during their 2 year term.

VP Track: Matt Chater nominated Gord Reddy for VP Track, and Stuart Lynne nominated Scott LaLiberte for VP Track. Both accepted their nominations, so the position goes to a vote. 61 votes were cast and 44 ballots were for Gord Reddy and 17 ballots were cast for Scott LaLiberte;

Thus, Gord Reddy is voted in as VP Track.

Please note that in some instances, some voters abstained as they did not know the candidates, as well some voters had two votes as they had a personal vote and a club vote.

Motion to destroy the ballots by Brian Storey. All in favour, motion passed.

14. New business:

Tabled to next AGM were the following topics:

- (a) UCI Riders riding at non-sanctioned events in BC – allowed or disallowed
- (b) VP Women's Cycling – potential addition to the Board of Directors
- (c) Anti-Doping – Cycling BC's stance and investigation into athletes potentially doping
