**8. Martin Farnham:** Reflection on 2024 and looking forward to 2025 and introduce Christine Reid.



9. **Christine Reid:** Announced the first Cycling BC Annual Report. Discussed increased communications and activity in the community with Member Meet and Greet, stronger financial oversight with contract fractional CFO and financial committee turning around a large deficit in 2023 to a small surplus in 2024.
10. **Scott Suffolk:** Summary of financial position, enhanced financial leadership and controls, strict budgeting and forecasting, strategic financial planning, minimal or no-pay increases for staff over the past few years, terminated office lease in 2024, moving to fully remote operation, staffing reduced by 4 full time positions over the past two years with existing staff absorbing the additional workload. Moved from \$134,000 deficit in 2023 to a \$3,000 surplus in 2024.

viaSport which is the agency responsible for overseeing amateur sport in BC offered a free governance review to all 70 or so of the Provincial Sport Organizations (or PSO's) that they look after and distributed grant funding to. viaSPORT commissioned a law firm called Sport Law to conduct this review. Christine, Martin and two staff members also met with Sport Law as part of the governance review. Sport Law released draft findings to us earlier this Spring, including some recommendations of changes to our Bylaws. The board reviewed these recommendations prioritized them and brought a set forward for a vote by the membership. Other recommendations may be taken up in the future.
